# CLEARANCE INFORMATION FOR BOARD-APPROVED ATHLETIC AND PARENT VOLUNTEERS

The following clearances are required for volunteering in the Purchase Line School District and must be renewed every 60 months:

- Pennsylvania Child Abuse History Certification
- Pennsylvania Criminal Record Check
- Federal Criminal History Record (Fingerprinting)\*
   \*Volunteers that have resided continuously in Pennsylvania for ten (10) years and swears in writing that s/he has never been convicted of a disqualifying crime in Pennsylvania or the corresponding offenses under the laws of any other jurisdiction may submit a signed "Volunteer Affidavit" in lieu of the fingerprint-based Federal Criminal History Record.

- When registering, be sure to use the following service code: 1KG6XN. Using the correct service code ensures the background check is submitted for the correct purpose. Fingerprinting requests processed through any other agency or purpose cannot be accepted and are not transferrable.
- Proceed to a fingerprinting facility:

- Submit the receipt received at the fingerprinting site which includes your Universal Enrollment ID to Purchase Line School District.

### **ADDITIONAL VOLUNTEER REQUIREMENTS:**

- All volunteers must sign an Arrest/Conviction Report and Certification Form (under Act 24 of 2011 and Act 82 of 2012). This form can be found on the PLSD website or obtained in the Superintendent's office.
- Volunteers must also submit verification of a recent tuberculosis test (less than three months old). This form can be found on the PLSD website or obtained in the Superintendent's office.
