



Golden Valley High School Guest Permission Request for All School Dances

Golden Valley High School is committed to providing a safe environment for students at all times. This includes dances held on and off campus. Golden Valley students may request that they be allowed to bring a guest to Homecoming.

Guests must be:

1. Currently a high school student (or)
2. Graduate of Kern High School District, not over 20 years of age (or)
3. May not be enrolled at a court or community school (or)
4. May not be under, nor have any pending, disciplinary action by any school district.

Golden Valley students (host) wishing to bring a guest must fully complete the reverse side of this page as directed and return it to the Dean's Office by (date) . Guest forms not received by this date will not be accepted and your guest may not be able to attend. Fill out this form completely before returning it and be sure to include a copy of the guest's driver's license or school ID as directed. All Golden Valley students must bring their school ID or a driver's license to every dance.

If a **student** host is asked to leave or removed from a dance for any reason, the guest must also leave the dance and the school/dance site and no refund will be issued. Transportation is not the school's responsibility.

If a **guest** is asked to leave or removed from a dance for any reason, the host must also leave the dance and the school/dance site and a refund will not be issued. Transportation is not the school's responsibility.

All guests are subject to the same rules and policies as students from the time they arrive to the time they leave. If a guest is a student at another KHSD school, s/he is also subject to KHSD policies and may be disciplined at his/her home school for wrongful actions at a Golden Valley dance.

This form will be at the entrance check-in for the dance and must be accessed by school personnel and the identity of the guest must be confirmed before the guest will be admitted. **The host and the guest must bring a photo ID to the dance or she/he will not be admitted.**
