### Catholic Family Parish Affiliation Form\*

The Catholic parishes of Vicksburg provide economic support for Catholic families who are actively involved in their parish church. The subsidized rate applies only to families who have a Parish Affiliation Form (PAF) signed by the pastor's signature. Returning families must submit a PAF to their parish office by March 1, 2018. New families are to submit a PAF to their parish office whenever they send their admission application to school.

### Making Vicksburg Catholic School Affordable

Families wishing to apply for reduced tuition for the upcoming school year may do so at any time during the Spring registration period or concurrently with Early Decision admission applications. **Complete an online application and submit the required supporting documents to FACTS Grant & Aid Assessment by April 1, 2018.**

All eligibility requirements must be met before a financial aid award will be offered:

- FACTS Grant and Aid application is completed online and verified (<https://online.factsmgmt.com/signin/3G06M>).
- VCS Registration is complete for the 2018-2019 school year.
- FACTS Tuition Management payment agreement is finalized for full amount of 2018-2019 tuition.

# TUITION & FINANCIAL AID

- Submission of a financial aid application does not guarantee an award for reduced tuition.
- A non-refundable application fee is required as final step of your online form submission.
- Copies of supporting documentation must be uploaded electronically, sent by fax or postal mail. These include 2017 Tax Federal tax return, 2017 W-2 forms for applicant and spouse, Social Security Income, Welfare, etc. Prepare your tax returns early to meet the school's April 1<sup>st</sup> deadline.
- FACTS Grant & Aid takes several weeks to process and verify applications.
  - Submit your online application and all supporting material as early as possible.
  - Late submissions will be eligible only for remaining available funds.
  - Respond promptly to any FACTS requests for additional information.
- Only K-12 tuition is eligible for reduction. Fees are due in full as shown on the schedule.
- No student will receive full and total aid.
- Students who have a poor discipline record (inappropriate behavior, violation of school rules, suspensions, etc.) will not be considered for financial aid.
- If you do not have access to the Internet, contact the school's Registrar (601-636-2256) to arrange a time to use a school computer.
- Should you have questions about logging in or the application process, contact a FACTS Customer Care Representative at 866-441-4637.
  - You will use the same log-in credentials for both your payment account and aid application.
  - Follow prompts to create a new account if you have never had a FACTS account. Your unique code for establishing your payment plan will arrive separately via email after registration is completed.
- Vicksburg Catholic School administrators will meet mid-April to allocate funds for 2018-2019.
  - Applicants will be notified via email after the final determination has been made regarding their request for financial aid (early-May).
  - Applicants must respond online (via email link) whether the award is accepted or declined. If the award is not accepted within 5 days, the offer will be forfeited.
  - Credit for financial aid will be applied to the family's FACTS tuition account after the electronic acceptance notice is received.

## **FACTS Grant & Aid Frequently Asked Questions**

Q. Who sets the application deadlines?

A. Application deadlines are set by your institution. If you are applying after the deadline, please contact your school to make sure your application will be accepted.

Q. Is the application process secure?

A. Yes. All documentation received is imaged upon receipt and then destroyed. Then, the application data becomes property of the applicable institution.

Q. What happens after I apply?

A. You can log into [online.factsmgmt.com/aid](http://online.factsmgmt.com/aid) to check the status of your application. Please allow two weeks for processing.

Q. Does the FACTS Grant & Aid Assessment process require a credit check?

A. No. FACTS does not require a credit check!

## **FACTS Agreement**

Tuition and fees are a contracted financial obligation to the school by parents/guardians upon the registration of their student. All financially responsible parents/guardians must have an agreement with FACTS Management Company (automatically renews each school year). Payment options are full pay or monthly pay. VCS will waive the FACTS enrollment fee if tuition and fees are paid in full by July 1, 2018. Monthly payment plans have an annual \$50 FACTS fee.

## **Payment Terms**

- Registration Fees are paid online separately via our Rediker registration website; due by March 3, 2018 for returning students; due within 10 days of acceptance for new students. An additional \$50 fee will apply if late.
- Tuition and Graduation Fees are budgeted items paid through FACTS Payment Plan. Term is June 2018 to May 2019. Available payment dates are the 5<sup>th</sup>, 15<sup>th</sup>, and 25<sup>th</sup> day of each month.
- Book/Building/Activity Fees are paid separately through FACTS Incidental Billing no later than October 1, 2018.
- After-school care fees are paid separately through FACTS Incidental Billing beginning September 1, 2018.
