CAH PARKING REGULATIONS

You have many personal responsibilities when driving an automobile on the CAH campus, as well as responsibilities for the welfare of others. All drivers are expected to abide by the rules pertaining to the parking areas/CAH campus, in addition to those outlined by the Department of Public Safety.

1. All vehicles parked on campus must have a valid parking permit. The parking permit **MUST** hang from the front rear view mirror at all time.
3. You may not allow another student to use your parking permit. If theft and use of another's parking permit is involved, campus consequences, including loss of parking privileges will be assigned.
4. Do not back into a parking space and have the car head the wrong direction. Park within the lines.
5. There is to be no parking where the curbs are painted red (fire lane).
- ^{[[L]]}_{SEP}6. Do not park in loading zones, visitor parking, handicapped parking, or teacher parking.
- ^{[[L]]}_{SEP}7. It is imperative that you not exceed the speed limit of **10 mph** while driving on campus.
8. Students are to leave their automobiles and clear the parking lot as soon as they have parked their vehicle.
9. No student will be allowed to ride or be transported in the back of a pickup truck while on the CAH campus. The driver of the pickup will be assigned consequences.
10. **ANY** and **ALL** drugs, alcohol, drug paraphernalia, illegal weapons found in vehicles on the CAH campus will lead to a full year suspension of driving privileges for the owner/driver of the vehicle, as well as other campus consequences.
11. If you have received a violation, you may be asked to show proper ID – Driver's license and proof of insurance.
12. **At no time are students permitted in the parking lot during the school day without first getting permission from the front office.**

CONSEQUENCES: I understand, if the above rules are not followed, the violation(s) may result in the following:

1. Discipline per discretion of the Principal/Ass't Principal
2. Parking privileges may be revoked; and/or, ^{[[L]]}_{SEP}
3. Car being towed; and/or, ^{[[L]]}_{SEP}
4. Citation ^{[[L]]}_{SEP}
