2018-2019 Academic Year

Following are the terms and fees for the 2018-2019 school year for the Georgetown/St John's bus program.

I agree to the following fee option and payment plan option through my FACTS payment account:

- One-time payment due on or before June 15th, 2018.
- Monthly payments with the first monthly draft payment due on June 1, 2018 or June 15, 2018, then monthly draft payments after that due on either the 1st or 15th day of each month for twelve months (Option I) or six months (Option II).

I understand that registration constitutes a full-year financial commitment (Option I selected above) or a full-semester financial commitment (Option II selected above) regardless of the extent of usage by the applicable student(s).

Aside from the exceptions listed below, I understand that my obligation to pay these fees are unconditional and that no portion so paid or outstanding will be refunded or cancelled, even if my child withdraws from or is otherwise suspended or dismissed from LCHS during the term of this contract. I also understand that no report cards or transcripts for participating students will be released until all financial obligations are paid in-full.

- I understand that if I withdraw my child from enrollment prior to June 1, 2018 this contract is null and void.
- If I withdraw my child between June 1, 2018 and August 1, 2018, I am released from obligation for the year's bus fees, except for 10% of the "Total Bus Program Fees Due for the 2018-2019 school year" listed at the top of this contract, which I authorize to be retained by the school.
- Cancellation notification must be sent in email or hand delivered to the Controller prior to August 1, 2018.

I further agree and acknowledge that:

- LCHS reserves the right to suspend or dismiss any student from the bus program whose personal conduct is unsatisfactory to the school administration;
- LCHS reserves the right to suspend or dismiss a student's bus riding privileges in the event of my violation of the Bus Payment option indicated above.

I understand the bus program will be conducted in reasonable compliance with information and directions included in the Bus Program Information document provided by the school, which I have read and understand.

I understand this contract will be null and void if a minimum of 10 student passenger commitments are not received by the school by June 1, 2018 in which case Lexington Catholic reserves the right to cancel the bus program.

***There will be a designated area at St. Johns for pickup and drop-off which will include an adult monitor provided by St. Johns.**

Inclement Weather Policy: Should Lexington Catholic High School have a delayed opening due to inclement weather, the bus schedule will be adjusted by the same delayed duration as the school's delayed opening. **Example:** The school has a 1 hour delayed opening, morning bus pick-up will be delayed by 1 hour and occur at 7:50 AM instead of 6:50 AM. If Fayette County schools are closed the bus will not operate. It will be the parent's responsibility to get them to school on those days.

Half Day Policy: Should the calendar call for a half day of school, the afternoon runs will commence/leave LCHS at 12:00 PM.

Exam Week Policy: During the week of exams, morning runs will remain the same but there will be only one afternoon run which will be scheduled for a 12:00 PM departure.

Student's responsibility while riding the bus:

1. Obey the driver's instructions. The driver of a school bus is in complete charge of students while they are on the bus. Complaints regarding discipline on the bus should be taken to the principal.
2. The driver has the authority to assign seats.
3. Students shall remain properly seated while the bus is in motion.
4. Never extend arms, legs or head outside the bus.
5. Refrain from talking to the driver except in an emergency.
6. Pets and animals, other than required service animals, are not permitted on the bus at any time.
7. No one shall tamper with any equipment or operate any part of the bus.
8. Do not mar or deface the bus. Students caught damaging bus equipment will be subject to disciplinary action and/or restitution.
9. There is to be no fighting or profanity on the bus or any loud disturbances.
10. Students must not wave or shout at pedestrians or occupants of other vehicles.
11. Do not throw objects from bus windows.
12. Do not throw waste paper or objects on the floor.
13. Eating or drinking is not permitted.
14. Use of tobacco products or drugs is prohibited.
