## Student Discipline

The following actions are listed in the Education Code (EC 48900 et. seq.) as warranting consideration for suspension and/or expulsion from school attendance:

- A. (1) Caused, attempted to cause, or threatened to cause physical injury to another person.  
(2) Willfully used force or violence upon the person of another, except in self defense.
  - B. Possessed, sold or otherwise furnished any firearm, knife, explosive or other dangerous object.
  - C. Unlawfully possessed, used, sold, or otherwise furnished, or been under the influence of a controlled substance.
  - D. Unlawfully offered, arranged or negotiated to sell a controlled substance, alcoholic beverage, or an intoxicant of any kind, and either sold, delivered, or otherwise furnished to a person an imitation.
  - E. Committed or attempted to commit robbery or extortion.
  - F. Caused or attempted to cause damage to school property or private property.
  - G. Stolen or attempted to steal school property or private property.
  - H. Possessed or used tobacco, or any products containing tobacco or nicotine products.
  - I. Committed an obscene act or engaged in habitual profanity or vulgarity.
  - J. Unlawfully possessed or unlawfully offered, arranged, or negotiated to sell drug paraphernalia.
  - K. Disrupted school activities or otherwise willfully defied the valid authority of school personnel.
  - L. Knowingly received stolen school property or private property.
  - M. Possessed an imitation firearm.
  - N. Committed or attempted to commit a sexual assault or sexual battery.
  - O. Harassed, threatened, or intimidated a pupil who is a complaining witness or witness in a school disciplinary proceeding.
  - P. Unlawfully offered, arranged to sell, negotiated to sell, or sold the prescription Soma.
  - Q. Engaged in, or attempted to engage in hazing.
  - R. Engaged in an act of bullying, including, but not limited to, bullying committed by means of an electronic act.
  - T. Aided or abetted the infliction of physical injury to another person.
- 48900.2 Attempted/committed sexual harassment (Grades 4-12 only).  
.3 Attempted/committed /threatened to cause an act of hate violence (Grades 4-12 only).  
.4 Harassed, threatened, or intimidated, creating a hostile educational environment (Grades 4-12 only).  
.7 Made terroristic threats against school officials and/or property (Grades 4-12 only).

**The following violations of EC 48915(c) require mandatory suspension and a recommendation for expulsion:**

- 1. Possessing, selling or otherwise furnishing a firearm.
- 2. Brandishing a knife at another person.
- 3. Unlawfully selling a controlled substance.
- 4. Committing or attempting to commit a sexual assault.
- 5. Possession of an explosive.

I have read this statement on student discipline and understand the severity of the above actions when committed on school grounds, at any school activity or when going to or from the school or school activity. I also understand that suspension and/or expulsion are the potential consequences of these actions.
