GOAL 1

Improve performance in English Language Arts and Math

- **ONGOING:** Providing 21st-century professional development opportunities
- **ONGOING:** Investing in more instructional coaches, social workers, case managers and library assistants to offer students and staff more guidance and support
- **ONGOING:** Expanding after-school intervention at all elementary and middle school
- **ONGOING:** Enhancing summer bridge and credit recovery opportunities
- **COMPLETED:** Hired two additional resource specialists



GOAL 2

Increase English learners' proficiency in reading, language arts and mathematics

- **ONGOING:** Offering a dual-language immersion program
- **ONGOING:** English learner intervention is provided at all school sites



GOAL 3

Continue to support highly qualified teachers and personnel

- **ONGOING:** Reducing class sizes
- **ONGOING:** Giving teachers access to up-to-date instructional materials, supportive instructional coaches, and resources to implement new state standards



GOAL 4

Ensure students are educated in safe and inspiring learning environments

- **ONGOING:** Continuing to invest in extra-curricular activities such as athletics transportation and equipment
- **ONGOING:** Modernizing school and district facilities, classroom tools and equipment, and provide trained professionals to assist with technology upgrades
- **ONGOING:** Increasing campus safety officers

- **COMPLETED:** Expansion of student success programs including behavioral support programs, STEM, Project Lead the Way, and CTE Pathways.



GOAL 5

Graduate all Lynwood Unified students from high school

- **ONGOING:** Continue to provide professional development and leadership opportunities
- **ONGOING:** LUSD is offering academic guidance and counseling services with more counselors and advisors at each middle school and high school
- **COMPLETED:** Expanded AVID to all elementary schools and added AP courses at Firebaugh High School



GOAL 6

Increase all students' college- and career-readiness and enhance career pathways

- **ONGOING:** Strengthening a variety of A-G courses that prepare students for college and career
- **ONGOING:** Enhancing Advanced Placement and International Baccalaureate programs, including AP/IB bootcamps
- **ONGOING:** Connecting students to digital programs that offer study guides, test prep, and post-high school planning tools
- **COMPLETED:** Increased PSAT/SAT prep and participation through College Day, offered college-prep workshops, and informational sessions



GOAL 7

Increase parent and community engagement

- **ONGOING:** Hosting college prep, academic support, student advocacy workshops, conferences and trainings for parents
- **ONGOING:** Investing in a special education interpreter and a parent involvement specialist

Notice of Non-Discrimination

The Lynwood Unified School District is committed to providing a safe school environment where all individuals in education are afforded equal access and opportunities. The District's academic and other educational support programs, services and activities shall be free from discrimination, harassment, intimidation, and bullying of any individual based on the person's actual race, color, ancestry, national origin or nationality, ethnic group identification, age, religion, political affiliation, family status, marital status or parental status, veteran status, pregnancy, physical or mental disability, medical condition, sex, sexual orientation, genetic information, gender, gender identity, or gender expression; the perception of one or more of such characteristics; or association with a person or group with one or more of these actual or perceived characteristics. Specifically, state law prohibits discrimination on the basis of gender in enrollment, counseling, and the availability of physical education, athletic activities, and sports. Transgender students shall be permitted to participate in gender-segregated school programs and activities (e.g., athletic teams, sports competitions, and field trips) and to use facilities consistent with their gender identity. The District assures that lack of English language skills will not be a barrier to admission or participation in District programs. LUSD prohibits harassment on the basis of a sex. Sexual harassment consists of any unwelcome sexual favors, and other verbal, visual, or physical conduct of a sexual nature, made by someone from or in the work or educational setting. Complaints of unlawful discrimination, harassment, intimidation, or bullying are investigated through the Uniform Complaint Process. Such complaints must be filed no later than six months after knowledge of the alleged discrimination was first obtained.
