Facility use by large groups that may create control, custodial, or maintenance problems will necessitate approval of the Superintendent and the posting of a \$2,000.00 security deposit. The District may require that District-approved security guards or staff be hired to protect the District interests.

The Board authorizes administration to negotiate appropriately the adjustment of fees for organizations with high demands for time and space due to excessive participation. The Board may approve or deny any adjustment.
