**Bibb County Board of Education met in Regular session on February 13, 2018, at 5:00 p.m. in the Central Office.**

**Mrs. Dailey made a motion to approve the agenda. Mr. Moody seconded the motion which passed unanimously.**

**Bethany Fields, \$100 to instruct Color Guard Camp at WBHS the week of March 19, 2018. Paid from local school funds.**

**Ashla Sullivan to be paid \$225 for instructing cheer clinic the week of Feb 26, 2018 and to provide routine clinic and cheer services at a rate of \$10 per cheer leader, per hour for WBHS. Funds will be paid from local school account.**

**Mr. Moody made a motion to approve contract for LaKeia McGlathery for teaching cheerleading clinic, West Blocton Middle School. Payment of \$150 will be paid from cheerleader funds. Mrs. Dailey seconded the motion which passed unanimously.**

Kade McGee, strength and conditioning consultant, Bibb County High School. Payment of \$2500 will be paid from the Bibb County Choctaw Boosters funds.

Mrs. Dailey made a motion to approve the following:

Brandy Barger to teach music and choir for August – December, 2017, and January – May, 2018. Payment of \$598.30 per semester will be paid from Centreville Middle general funds. Mr. Moody seconded the motion which passed unanimously.

Approval to contract with Ashlie Cash to teach choreography for CMS majorette tryouts and clinic. Payment of \$50 will be made from majorette funds.

Approval to contract with Kathy Smith for technology training with students and teachers through May, 2018. Payment of \$75 per day will be paid from Randolph Elementary PTO funds.

Approval to contract with Karen Hubbard to provide tutoring services. Payment of \$25 per hour will be made from set aside Title I funds according to state and federal guidelines.

Approval to increase rate of pay for extra clerical work for Kenina Lynch from \$10 per hour to \$12 per hour effective February 14, 2018. Payments are from federal funding sources.

Approval for payment of 4 days labor at pre-school for Madalyn Watkins prior to completion of Appleton application. Payment of \$13.43 per hour will be made from district general funds.

Approval for Bibb County Career Academy automotive class, 6 students, to travel to Chattanooga, TN. Students will compete in Hot Rodders of Tomorrow Engine Challenge qualifying event. Students will travel by personal transportation accompanied by Mr. Max Gray and Mr. Allen Franklin on Friday April 14, stay overnight and return on Saturday April 15<sup>th</sup>. The trip is funded by Career Technical funds.

Approval for Bibb County High School Softball team to travel to Gulf Shores. The team and 2 coaches will travel April 26-29<sup>th</sup>, 2018. The team will travel by private/parents vehicles and will stay 3 overnights.
