Guidelines for Reporting dangerous Students

The Buena Park School District office will monitor and keep a list of district wide suspensions and expulsions. Student discipline records as well as suspension forms will be kept at the school site. A confidential notebook will be kept in the school office and made available to teachers and appropriate staff for the purpose of informing individuals about any dangerous or potentially dangerous students. Upon readmission to the school following disciplinary action, the principal will notify the student's teacher(s) about the incident, action taken, and behavior contract or conditions to support the student's participation in school.

Site Policy regarding Notification to Teachers regarding Dangerous Students

Teachers will be notified by the principal of students enrolling in their classes who have had a history of being dangerous to themselves and/or others.

The opportunity to review the cum/records of the student will also be made available to the teacher.

To the extent possible, the students information will be kept confidential, and only shared with personnel who need to know the information in order to provide appropriate student services.
