Based on the National Reading Panel report, teachers are skilled at assessing, diagnosing and delivering instruction in the five areas of reading, Phonemic awareness, phonics, fluency, vocabulary and comprehension. To support math instruction the school is highly engaged in Cognitively-Guided Instruction, and the Math + Music program from the MIND Institute. Social Studies and science uses hands-on, inquiry-based techniques to make the curriculum come alive. All of the subject areas are supported by the use of technology. The staff carefully reviews intervention programs and teaching strategies so that they can increase their repertoire of skills to meet the individual needs of students.

Students are supported in their learning with the After School Academy, Kindergarten English Academy, Title 1 support services, Morning Math, and the Twilight Program.

All students are accepted and welcomed at Perry, and as a result, feel comfortable at School. We pride ourselves on the diversity of ethnicity, economics, and learning styles. Perry School offers a program for gifted, English Language Learners, Title 1 students and special education. Our offerings in special education are combined for the best possible Individual Education Plan and we can combine, speech, resource, special day class, mainstreaming, full inclusion, to meet the child's unique needs. We work with the whole student population using the 40 Developmental Assets Programs and Second Step, a bully prevention program. Perry School, constructed in 1964, consists of 6 separate buildings including an administration building with office and library, a multipurpose room, four classroom buildings, with 28 total classrooms and a computer lab. The site also has 4 portable classrooms, added in the 1990's and a YMCA portable building used for before and after school child care.

Rain gutters and exterior trim was painted on all buildings. Wooden ramps were replaced with concrete ramps on 4 portable buildings.

Interior and exterior lighting was upgraded with more efficient lighting in all areas. Lighting sensors were installed in all classrooms and restroom buildings.

Facilities are inspected continuously by custodial and maintenance personnel and work orders are submitted as needed.

Standardized Testing and Reporting Program

The Standardized Testing and Reporting (STAR) Program consists of several key components, including the California Standards Tests (CSTs); the California Modified Assessment (CMA), and the California Alternate Performance Assessment (CAPA). The assessments under the STAR program show how well students are doing in relation to the state content standards. The CSTs include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and nine through eleven. The CAPA includes ELA and mathematics in grades two through eleven, and science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations. The CMA is an alternate assessment that is based on modified achievement standards in ELA for grades three through nine, mathematics for grades three through seven and Algebra I and science in grades five, eight, and ten. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations. On each of these assessments, student scores are reported as performance levels. Professional Development

This section provides information on how teachers and staff are trained for instructional improvement.

The teaching/learning interaction is the cornerstone of a good instructional program. To improve the quality of the program, Perry School staff engages in staff development. Teaching is an ongoing art and requires training throughout a teacher's career. All training and curriculum development at Perry School revolves around the California State Content Standards and Frameworks. Just as we hope for Perry students, Perry teachers are lifelong learners.

Huntington Beach City School District regularly collaborates with all levels of district and school site staff when developing professional development activities in alignment with the No Child Left Behind Improving Teacher Quality Expectations. Instructional program improvement is driven by student needs and guided by state standards and frameworks. District and school administrators use site trend analyses, state testing, district-level assessments, teacher response, and administrator observations to identify more effective methods and strategies to achieve positive results for teachers and students.

The Assistant Superintendent of Educational Services and principals meet monthly to analyze current instructional programs, instructional materials, implementation timelines, and student achievement. Feedback is gathered at the site level through direct input and staff observation. Periodic Curriculum Development Committees are formed to address identified areas of need and focus. In the 2005-06 school year, three mandatory staff development days were held during the school year. District-level training activities and professional development revolved around the new language arts textbook adoption and differentiated instructional strategies to meet the needs of all students.

On an annual basis, the Perry school staff looks at the district and state assessment data, classroom portfolios, and work samples to determine the needs of students. Each grade level makes recommendations for new additional strategies, training, or supplemental materials that may help students in the learning process. Teachers align classroom curriculum to ensure that all students either meet or exceed state proficiency levels. Articulation between grade levels helps to give consistency to the school program. Dynamic Indicators of Basic Literacy Skills (DIBELS), Thinking Maps

A portion of our school funds is used to enable staff members to attend teaching seminars and other events designed to enhance their teaching techniques and expand their knowledge base. Teachers new to the profession are supported by peer coaching and are encouraged to attend inservices offered by the West Orange County Consortium for Special Education or education consultants. Teachers are encouraged to attend subject-specific seminars and major conferences and share what they learn with other staff members. The Beginning Teacher Support and Assessment (BTSA) program offers additional support and opportunities to new teachers. The program is designed to assist those new to teaching to expand and deepen their teaching skills, help the school district retain more new teachers, and improve learning opportunities for students.

Classified staff and instructional assistants are provided training and development opportunities at the school, district, and county levels. Inservices for classified staff are geared to their specialty areas.

NCLB Requires evaluation of student performance both schoolwide and by specific subgroups within the student population. Earobics, Accelerated Reader, 6 minute solution, Language!, Read Naturally and Phonics for Reading are a few of the interventions programs being implemented.

The Beginning Teacher Support and Assessment (BTSA) program offers additional support and opportunities to new teachers. The program is designed to assist those new to teaching to expand and deepen their teaching skills, help the school district retain more new teachers, and improve learning opportunities for students.

For experienced teachers, the Peer Assistance and Review Program utilizes the district's veteran teachers as "consultants" to assist with staff development districtwide, with a particular focus on teacher needs.
