



## **CSEE ATHLETICS PLAYER/PARENT CONTRACT**

1. A student athlete must be in good academic standing with CSEE otherwise they will automatically become ineligible for the program. A study hall has been included as an additional component of the athletic program to allow students the time to complete homework, prepare for upcoming exams, and receive extra help if needed. Students will also receive daily progress reports which must be submitted to coaches on a daily basis in order to track homework, classroom conduct, and overall performance.
2. All student athletes **MUST** report to school in full school uniform on a daily basis. If a student athlete reports to school out of uniform, he/she will not be permitted to attend practice and may face disciplinary actions through the athletic program that may lead to expulsion from the program.
3. Student athletes must report to practice with the necessary attire (sneakers, shorts, t-shirt, etc.). We recommend storing these garments in a separate bag. Students will have time to change in the locker room before practice.
4. Student athletes are expected to attend school regularly and report to all of their classes and be on time. If a student athlete is absent from school or cuts a class, he/she is not permitted to participate in practice that day.
5. Student athletes are expected to follow CSEE's Code of Conduct. This includes and is not limited to appropriate behavior in the classroom, school, and school bus (if applicable). Teachers will have a list of all athletes and will report any student that is not meeting the standards for participation in the athletic program. Consequences for discipline violations are at the discretion of the athletic director and/or principal.
6. Parents/guardians must pick up their child at 6:30 pm **SHARP**. Failure to pick your child up on time on a consistent basis will result in the student being removed from the team. Students will be dismissed through the main entrance. Parents/guardians must wait outside of the school in the parking lot for their child to be dismissed. Parents are **NOT** permitted to enter the school during practices.

7. Players are responsible for the safekeeping and care of their uniforms and equipment that are provided by CSEE during their participation in the program. Failure to return a uniform/equipment and/or any items loaned to the players during the season will result in the parent/guardian being responsible for replacing any lost, unreturned or damaged items.
8. Parents/guardians must attend ALL meetings regarding their child's specific sport. There will be approximately two to three meetings throughout the year.
9. Parents/guardians give student athlete permission to have pictures/video taken relating to the athletic program. This includes but is not limited to website postings, game videos, team pictures during games and during practices, press releases, media coverage, etc.
10. Transportation will be provided for all events relating to the CSEE Athletics. Students are only allowed to leave a game or other basketball related event in which transportation is provided with a parent or guardian whose name appears on the emergency contact card. NO EXCEPTIONS.
