SLSPA Board of Trustees Minutes 04 12 2016

Ron presented a new policy that addresses Online Classes. The verbiage of the proposed policy is below:

SLSPA - Online Class Policy

All students will be enrolled into Highland High School for academic classes based upon the SLSPA 4 year academic track. Students that wish to take classes online for original credit may do so prior to the start of the academic year based upon the SPA four year academic track plan. In order for a student to not be scheduled into a class, a transcript with the completed credit from an "Advanced Ed" accredited institution must be submitted to the counselling office by August 5th of the upcoming school year. Failing to do so will result in the student being enrolled in a Highland campus class until the online credit has been received and verified by the counseling center.

Sue Ann motioned to approve the online class policy. Kit seconded the motion. The motion passed unanimously.
