Eighth Annual CIF State Girls Wrestling Championships Friday-Saturday, February 23-24 at Visalia Convention Center Figueroa and Martinez of Selma Seeking Rare Four-Time State Champion Title

SACRAMENTO, **CALIF.** – The eighth annual CIF State Girls Wrestling Championships are February 23-24 at the Visalia Convention Center in Visalia.

At last year's event Gracie Figueroa (126-pounds) and Alleida Martinez (111-pounds), both of Selma, became three-time champions, only the third and fourth girl wrestlers to do so in CIF State history.

Selma (111 points) claimed their second consecutive team Championship, with Corona (83 points) and Tokay (73.5) taking second and third place respectively.
