CHARTER RENEWAL CRITERIA

In accordance with Education Code §§ 47605 and 47607, in order to renew a charter, the District must determine whether the charter school has met the statutory requirements. Pursuant to the requirements of SB 1290, the District “shall consider increases in pupil academic achievement for all groups of pupils served by the charter school as the most important factor in determining whether to grant a charter renewal.” Ed. Code § 47607(a)(3)(A).

REPORT GUIDE

In conducting oversight as a charter school authorizer, the District places an emphasis on performance and compliance with applicable law, policy, and the approved charter, as well as on the lead fiduciary role of a charter school’s governing board in the overall success of the school for students. Information gathered through oversight serves as part of the school’s ongoing record of performance and provides important data for the CSD, LAUSD Superintendent, and ultimately the LAUSD Board of Education in making informed decisions about charter school authorization. In designing this document, the District has considered California charter school law, as well as the California State Board of Education’s criteria for evaluating charter schools and the National Association of Charter School Authorizers’ *Principles and Standards of Quality Authorizing*. This reporting tool provides guidelines and criteria used by the CSD to observe, record, assess, and reflect with the charter school on school performance as captured during the annual oversight visit process in these four categories:

Governance – demonstrating fulfillment of the governing board’s fiduciary responsibility to effectively direct and provide oversight for the charter public school, including but not limited to enactment and monitoring of policies and procedures to ensure the school’s full compliance with applicable law, policy, and the terms of the charter approved by the LAUSD Board of Education

Student Achievement and Educational Performance – demonstrating academic achievement and growth for all students

Organizational Management, Programs, and Operations – demonstrating effective leadership and implementation of the governing board’s policies and procedures, as well as the school’s educational program and systems and procedures for the day-to-day operations of the school

Fiscal Operations – demonstrating sound fiscal management, appropriate use of public funds, and compliance with regulatory requirements

This report, including the ratings in each category, is based on information and evidence gathered at the time of the annual oversight visit. The CSD considers evidence provided through CSD staff observations, document review, interviews, and discussion with school representatives. All charter schools are expected to prepare for the visit and have available, as applicable, all documentation requested in the *Annual Performance Based Oversight Visit Preparation Guide 2016-2017*. The “Sources of Evidence” sections below identify key information sources generally relevant to their respective indicators; these lists are not exhaustive, however, and some items may not be applicable to the grades served. Schools may present additional evidence as deemed relevant and appropriate. As needed, CSD staff also may request additional information and/or documentation prior to, during, and/or following the visit.

The tool employs the following four-point rubric to rate the school’s performance in each category: (4) *Accomplished*, (3) *Proficient*, (2) *Developing*, and (1) *Unsatisfactory*. In addition, the *Summary of School Performance* section in each category captures key findings under one or more of the following headings: (1) Areas of Demonstrated Strength and/or Progress (Note: potential “promising practices” are identified within this section with an asterisk [*]); (2) Areas Noted for Further Growth and/or Improvement; and, if applicable, (3) Corrective Action Required. Under “Corrective Action Required,” the CSD reports findings of material noncompliance with applicable law, LAUSD charter policy, or the school’s approved charter. If the report includes any findings under “Corrective Action Required,” the charter school must take immediate and appropriate steps to remedy the identified concern. In accordance with its “tiered intervention” approach to charter school non-compliance and poor performance, the CSD may also send the school appropriate notices, separate and apart from this report, to provide and document time-specific follow-up as necessary. At the other end of the spectrum of performance, any school that earns a rating of *Accomplished* in any category is encouraged to submit to the CSD a summary of those “promising practices” that the school believes have contributed to its success, in order to support the CSD’s ongoing efforts to promote and facilitate reciprocal sharing of promising practices among education leaders from across the entire portfolio of LAUSD schools.

The Governing Board’s 2016-2017 meeting calendar, board meeting agendas and minutes are posted on the school’s website to increase stakeholder’s access to this information. ✓ (G3) To further ensure appropriate due process for its stakeholders, the UCP and complaint resolution procedures were added in the 2016-2017 Parent-Student handbook as a means of providing clearly delineated processes for the UCP and for complaints outside of the UCP. <p><u>Areas of Demonstrated Strength and/or Progress</u></p> <ul style="list-style-type: none"> ✓ (A1, A2) 2015-2016 SBAC subgroup data in ELA reveals the percentage of students who met or exceeds standards are for Latino 41%, SED 43%. These outcomes represent a larger percentage of students than the District, whose SBAC results reveal 33% for Latino students and 33% for SED students. Similarly, in Math, EQ2 outcomes reflect 29% for Latino students, 31% for SED versus the District’s 23% and 23% respectively. ✓ (A3, A4) On the 2015-2016 CAASPP (SBAC) assessment in English Language Arts, 44% of Equitas Academy 2’s students Met or Exceeded the performance standards, which exceeds the Resident Schools Median of 23%. <p><u>Areas of Demonstrated Strength and/or Progress</u></p>	
<ul style="list-style-type: none"> ✓ (O3) The school is strengthening services and supports, particularly for EL and Special Education students, in several ways. Through a collaborative partnership, the school has funded an EL Specialist for the 2016-17 school year to increase teacher professional development and coaching on language acquisition, and to support the learning challenges of English Learner students who also have a learning disability. School leaders are working to ensure that all teachers support EL and Special Education students with visual aids including PowerPoints with written direction, images, anchor charts and visual prompts in addition to providing sentence frames in writing to help students to learn to communicate academically and thoroughly. The school is using a differentiated reading program (iReady) to build reading and language skills at each student’s individual level. ✓ (O4) A key feature of Equitas’ educational program is to provide a structured, achievement-based community that prepares students to graduate from college preparatory high schools, four-year colleges and universities. A tour of classrooms affirm that the academic program is centered on mastery of foundational skills in literacy and mathematics. Classroom environments reflect the emphasis of a college-going school culture with students being referred to as scholars and classrooms identified with names of colleges, as just a few examples. ✓ (O8) The school has a strong system in place for communicating with stakeholders. For example, an LCAP survey was distributed in May 2016 to families, staff and students which yielded 408 responses. Survey results were analyzed, used to identify 2016-2017 school goals, and the findings were presented via a PowerPoint presentation. The school’s use of Illuminate, a student information system, is also being used to capture parent contacts with teachers and the topic addressed. The school continues with its practice with monthly Cafecitos in order to provide time for parents to meet with school staff and leadership to discuss current events and provide input. In a focus group with 11 parents selected by the school, parents shared that they are pleased with many aspects of the school, including the academic quality of education, the structure at the school, and the teachers who provide academic support after school. Parents stated that teachers communicate with them in a variety of ways, such as text messages, emails, telephone calls and notes. In a stakeholder interview of 5 teachers selected by the school, teachers reflected on how they are encouraged to find solutions at the school site and to make recommendations to leadership about areas for improvement. 	
<p><u>Areas Noted for Further Growth and/or Improvement</u></p>	
<ul style="list-style-type: none"> • (O1) To strengthen the school’s health and safety practices, the school is encouraged to have separate drills for lockdown and earthquake preparedness (versus combining these drills). • (O3) The 2016-2017 EL Master Plan indicates as part of its reclassification criteria “CST results in ELA at the Basic, Proficient, or Advanced level.” The EL Master Plan shall be revised given CST results in ELA are no longer available. • (O6) Schools leaders shared that the implementation of the school’s discipline system was inconsistent due to staffing challenges faced during the school year, resulting in an increase in suspensions (4.4% versus 2.2% the previous school year). School leaders are committed to ensuring consistent implementation of the school’s behavior systems. This began by bringing on a new school leader with identified skills in student discipline focused on positive behavior supports; the addition of a School Leader Resident; and new teachers were trained in the implementation of Equitas’ culture rubric and the Kickboard behavior support system. The school began implementing the Dynamic Mindfulness process as part of their Restorative Justice Framework to help students develop socio-emotional learning. Finally, a new accountability system using behavior data dashboards was instituted to proactively identify inconsistencies in the application behavior systems at the school.

CSD staff attended Equitas’ board meeting on September 22, 2016 where revised language was adopted by the board to address this concern. (O3) On September 27, 2016 at the oversight visit for the sister school, Equitas Academy 3, the organization provided evidence of an updated EL Master Plan with reclassification criteria that no longer includes CST results.
