IPM statement

It is the goal of Fountain Valley School District to implement IPM by focusing on long-term prevention or suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

Our pest management objectives are to: *(Example: Focus on long-term pest prevention)*

The Fountain Valley School District Integrated Pest Management Program is a sustainable approach to manage pests by combining cultural, physical and chemical tools in a way that minimizes economic, health and environmental risks while providing for a safe and inviting educational setting.

Pest management contracting

Pest management services are contracted to a licensed pest control business. Pest Control Business name(s) California Pest Management Inc., Pro Pacific Pest Control, Western Exterminator Co., Terminex

Prior to entering into a contract, the school district has confirmed that the pest control business understands the training requirement and other requirements of the Healthy Schools Act.

Pest identification, monitoring and inspection

Pest Identification is done by: IPM Coordinator, Orange County Agricultural Commission, Calif. Pest Mgmt., Western Exterminator Co.

Monitoring and inspecting for pests and conditions that lead to pest problems are done regularly by Custodians and results are communicated to the IPM Coordinator.

Specific information about monitoring and inspecting for pests, such as locations, times, or techniques include:

(Example: Sticky monitoring boards are placed in the kitchen and are checked weekly by custodial staff.)

Direct and indirect periodic assessment of pests by staff in kitchens, lounges, offices, classrooms, and landscape. Sticky traps are periodically inspected by California Pest Management Inc.

Chemical pest management practices

If non-chemical methods are ineffective, the school district will consider pesticides only after careful monitoring indicates that they are needed according to pre-established action levels and will use pesticides that pose the least possible hazard and are effective in a manner that minimizes risks to people, property and the environment.

- Reports of all pesticides applied by school district staff during the calendar year, except pesticides exempt¹ from HSA recordkeeping, are submitted to the Department of Pesticide Regulation at least annually, by January 30 of the following year, using the form provided at www.cdpr.ca.gov/schoolipm. (Education Code Section 16711)

¹ These pesticides are exempt from all Healthy Schools Act requirements, except the training requirement: 1) products used in self-contained baits or traps, 2) gels or pastes used as crack and crevice treatments, 3) antimicrobials, and 4) pesticides exempt from U.S. EPA registration. (Education Code Section 17610.5)
