- I. **Call to Order:** Meeting was called to order by Kevin Glynn at 3:22 pm.

- III. **Review of Bylaws:** Dr. Yoon presented background information about the current Bylaws which were redone in 2014 to incorporate the mandated District guidelines for School Site Councils. She pointed out some corrections that needed to be made:
  1. **Article V: Meetings of the School Site Council**
    - a. **Section A. Schedule** - bolded words should be changed to **last Tuesday**
    - b. **Section F. Special Emergency Meetings** - this section should be amended to read that **NO** emergency meetings are allowed.
  2. **Article VI: Bylaws of the School Site Council**
    - a. **Section B. Amending Bylaws** - the number thirty (30) should be amended to read three (3)
  3. All Article Titles should not be bolded, items in bolded text should only be the items that members have the option to change.

Further discussion ensued regarding the composition of the council with a recommendation that since it is increasingly difficult to achieve quorum and with declining enrollment, perhaps a smaller council would be wise. The minimum number required is twelve (12) members, we currently have sixteen (16). **Ms. Haye moved to reduce the SSC council makeup to twelve (12) beginning in the 2017-18 school year. Ms. Kleifield seconded. It was clarified that the reduced council makeup would consist of 1-Principal; 4-Teachers; 1-Other School Personnel; 3-Parent/Community; 3-Students. Vote resulted in seven (7) in favor; one (1) opposed; one (1) abstention. Motion carried.**

Upon further discussion, **Ms. Kleifield moved to hold annual elections for ALL seats in lieu of 2 year terms with alternating elections. Second by Ms. Gotzeva. Vote resulted in eight (8) in favor; one (1) opposed. Motion carried.**

- IV. **Title 1 Budget:** Dr. Yoon presented information that as of October 2016 there is \$72,870 pending distribution in the Title 1 Budget. This money must be used this year. She recommended, based on school needs and teacher input, that the school purchase one additional day of school nurse for \$23,000 and that the remainder go towards purchasing technology. (Differentials for coordinators were withdrawn as they are funded elsewhere). **It was moved and seconded to accept Dr. Yoon's recommendation. Vote resulted in seven (7) in favor; one (1) opposed; one (1) abstention. Motion carried.**
