

**ST. PIUS V CATHOLIC SCHOOL
EXTENDED DAYCARE PROGRAM
REGISTRATION CONTRACT 2016-2017**

FAMILY NAME OF STUDENT:

I, the undersigned parent/guardian request registration of my child in St. Pius V School Catholic School Extended Daycare Program. I acknowledge I have read, understand, and support the content and rules stated in the St. Pius V Extended Daycare Handbook. I understand all Extended Daycare forms must be completed before my child may attend the program.

1. I agree to pay the registration fee in the amount of \$50.00 per family for the 2016-2017 school year. This fee is non-refundable and will not be applied to monthly charges. Students will not be allowed admittance to this program until the registration fee is paid in **full and all emergency forms have been turned in.**
2. My child will attend _____ mornings, _____ afternoons, _____ both, and _____ occasional use.
3. If my child attends on an occasional use basis, I will inform Extended Daycare of days they are coming in the afternoon. I agree to pay a fee of \$10.00 should I fail to do so.
4. I agree to pay the full monthly rate for all months including those shortened by holidays. On ½ days, daycare is offered at no additional charge.
5. I agree to pay a penalty fee of **\$1.00 per minute per child** if my child/children are not picked up before 6:00 p.m.
6. I agree to pay \$25.00 late fee each month that the account is delinquent. The school may, at its sole option, permanently terminate the attendance of any student when payment of any fees for this program is in arrears.
7. Failure of parent to notify the Extended Daycare Program when a regularly attending child will not attend will result in the parent being charged a \$10.00 non-notification fee each time the child fails to attend.
8. I further understand that fees for this program are separate from school tuition and other fees associated with St Pius V Catholic School and that these fees are to be paid separately.
9. As a condition of continued attendance, each student and his/her parents are required to acquaint themselves with school regulations as stated in the Parent Handbook and their school contract. From time to time, the School Administration may issue bulletins to the students and/or parents covering new regulations or the amendments of existing ones.
10. I understand that this program is an extension of the school day and will direct my child/children to adhere to all school policies. Any student in this program who breaches any school regulation is subject to such disciplinary actions, as the school deems necessary.
11. I understand that the parents/guardians must sign the child/children into the before-school sessions and must sign the child/children out of any session during the day. A child will only be released to those whose names appear on the sign out/pickup authorization forms. Phone calls and fax to release students will not be accepted.
12. It is understood by the undersigned parents/guardians of the aforementioned student(s) that this application for registration is a contract with St. Pius V Catholic School Extended Daycare Program to provide daycare services for fees and any other charges established by the School Administration for the school year 2016-2017.
13. I understand personal items such as toys CD players, Walkman, Game Boys, cameras etc. are not to be brought to daycare.
14. **I will assure my child's emergency contacts are kept up to date.**
15. I will keep Extended Daycare informed of any current medical problems my child may have.
16. **I understand there will be no afternoon daycare offered on September 22, 2016.**
17. I understand my child must bring homework supplies to the homework room, and that classroom behavior is expected during homework time. I further understand that disruptive children will be sent from the room, and may not be allowed to return.
18. **I UNDERSTAND THAT THE ULTIMATE RESPONSIBILITY FOR OVERSEEING MY CHILD'S HOMEWORK IS MINE.**
