DESIGN

TERMS OF THE CONTRACT AGREEMENT

- The deadline for placing newspaper advertisements is 8 days prior to the publication date.
- The client agrees to provide either a camera-ready advertisement or the art and copy necessary to create an advertisement. Black and white copy is required. Colored ink or paper is unacceptable.
- Advertisers will receive a copy of the newspaper.
- Payments. To qualify for the "10% or 20% Discount," payment must be made when the contract is signed. Billed accounts are payable within 30 days of the invoice date. Ads that are not paid for may be pulled from the next scheduled issue.
- We reserve the right to refuse advertising. The newspaper may refuse advertising which is deemed inappropriate for a high school publication.
