## FOR LONG-RANGE FACILITY MASTER PLAN OVERSIGHT COMMITTEE

The Governing Board of the San Gabriel Unified School District needs to fill vacancies on its Long-Range Facility Master Plan Oversight Committee.

The Oversight Committee was formed in September 1998 to provide independent monitoring of all implementation phases of the Long-Range Facility Master Plan.

### **Purpose**

The Committee shall actively review and report on the proper expenditure of taxpayers' money for school construction and shall convene to provide oversight for the following:

1. Ensure that bond revenues are expended only for the construction, reconstruction, rehabilitation or replacement of school facilities, including the furnishing and equipping of school facilities, or the acquisition or lease of real property for school facilities.
2. Ensure that no prohibited expenses are made.
3. Ensure that facilities expenditures and programs are consistent with the San Gabriel Unified School District General Obligation Bond Allocation and Implementation Plan and with the stated goals of the Long-Range Facilities Master Plan document.
