

PARENT CERTIFICATION:

CODE OF CONDUCT:

PARTICIPANTS: Be sure that you understand the “Code of Conduct.” Any person violating these rules may be sent home at their own expense. I agree that I will be financially responsible for all costs accrued for this return trip of the student and sponsor if necessary. I will reimburse TCSD the full amount due within 10 days of this action. Any person violating these rules may cause other participants to be sent home and may otherwise disqualify the entire group from participation.

All participants will be expected to conduct themselves in a manner best representing the school and the TCSD. In order that everyone may receive the maximum benefits from his/her participation, the “Code of Conduct” must be followed at **ALL** times:

- I will at all times, respect all public and private property, including the hotel/motel in which I am housed.
- I will spend each night in the room of the hotel/motel to which I am assigned.
- I will strictly abide by the curfew established and shall respect the rights of others by being as quiet as possible after curfew.
- I will not be in the room of the opposite sex at any time during the activity.
- I will not use alcoholic beverages, tobacco, or abuse/use illegal drugs.
- I will not leave the hotel/motel without the permission of my advisor, coach, chaperone, or school administrator.
- I will not be involved in any serious misbehavior including shoplifting, vandalism, and/or theft.
- My conduct shall be exemplary at all times.
- I will keep my advisor, coach or chaperone informed of my whereabouts as all times.
- I will, when required, wear an official identification badge.
- I will attend, and be on time for all activities that I am assigned to and registered to attend.
- I will adhere to the school dress code and policies during the entire activity.

VIOLATIONS AND PENALTIES:

I agree that if, for any reason, I am in violation of any of the rules of the competition, performance, activity, or conference, I may be brought before the appropriate discipline committee for an analysis of the violation. I also agree to accept the penalty imposed on me. I understand that any penalty and reasons for it will be explained to me before it is carried out. I further realize that the severity of the penalty may increase with the severity of the violation, to the extent of being immediately sent home at my own expense.

Violations of any of the above listed items could result in warning and reprimand to dismissal from team and/or competition. Notification of the violation and the action taken will be sent to the participant’s principal and parents/guardians.
