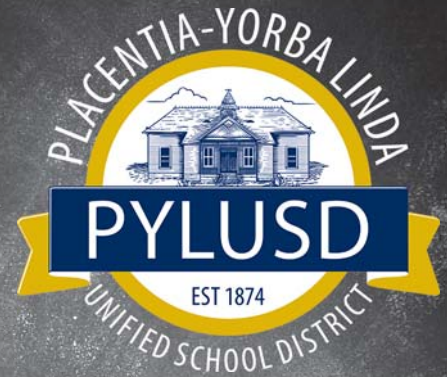


BOARD HIGHLIGHTS

Notes from the **Tuesday, Sept. 13, 2016** PYLUSD Board of Education Meeting



Board Actions

1. Staff appointments

The Board took action to appoint a new Administrator-Energy Manager, two new Program Specialists, three new Psychologists (two of which are 60 percent) and a new Coordinator in Special Education.

2. Immunizations

The Board took action to adopt revised Board Policy 5141.3, "Immunizations," second reading.

3. Week of the School Administrator

The Board took action to designate the week of October 9-15, 2016 as "Week of the School Administrator." Yorba Linda High School Principal Dave Flynn – last year's Certificated Manager of the Year – read the proclamation at the meeting.
