### ADMISSION AGREEMENT

The file will include this admission agreement, emergency care information, photographic release form, and the student activity schedule. The information in a student's file is confidential and may be reviewed only by the parent/guardian, an authorized representative of the Bright Futures After School Program, District personnel, or an authorized representative of the California Department of Education.

**Policies:** All policies related to the Bright Futures After School Program are included in this agreement or in the Dorothea Lange School Student Handbook.

**Parent/Guardian Acknowledgement:** BY SIGNING MY INITIALS NEXT TO EACH SECTION BELOW, I agree that both I and my son/daughter will follow the Bright Futures After School Program procedures:

\_\_\_\_\_ I acknowledge there is no charge for the Bright Futures After School Program.

\_\_\_\_\_ I agree that my son/daughter will **attend:**

**Elementary After School program (GRADES 1-6)** for a minimum of 5 days per week until at least 6:15 PM totaling 3 hours per day. The program is open 5 days per week from 3:15 PM until 6:15 PM, and my son/daughter must attend all 5 days. He/she will be signed in each day he/she attends at Dorothea Lange. All students must be signed out before leaving campus by an authorized adult and will be released after 3 hours per day or with enough time to reach home before dark.

\_\_\_\_\_ I understand regular attendance is required and will submit a note when my son/daughter is absent. If my son/daughter has more than 3 unexcused absences he/she will be dropped from the program.

\_\_\_\_\_ I understand my son/daughter may sign in late after alternate programs or appointments.

\_\_\_\_\_ I understand the behavioral expectations and attendance requirements, which are outlined in the Dorothea Lange School Student Handbook, will be followed during the Bright Futures After School Program. Inappropriate behavior as defined by the Lucia Mar School District and Bright Futures guidelines may also lead to school disciplinary action and/or dismissal from the Bright Futures After School Program.

\_\_\_\_\_ I agree that my student will have academic support and enrichment activities during their attendance in the program.

\_\_\_\_\_ I understand that my student will receive a free, healthy snack after school daily. Please list any food allergies your son/daughter on the attached Emergency Card.

\_\_\_\_\_ I will submit complete emergency contact information on the attached Emergency Card with the names of four (4) adults who are authorized to pick up my son/daughter. I will update the **Emergency Card whenever a change is needed such as: a new phone number, employment change, additional authorized people, etc.**

\_\_\_\_\_ I understand that only myself and other adults listed on my son's/daughter's Emergency Card will be allowed to pick up my son/daughter and that all students must be picked up by 6:15 PM. Continued lateness will result in the student being dismissed from the program.

\_\_\_\_\_ I give my permission for my son/daughter to watch PG movies, as approved by the Bright Futures Staff.
