School Facility Conditions and Planned Improvements (Most Recent Year)

Wayside School was built in 1949 and modernized in 1993. It sits on 8.29 acres of which 3.78 acres is playground. This school has 38 classrooms, a multi-purpose center, library, bookroom, two pre-k classrooms, reading lab, and office room. The campus also has a staff lounge and a workroom.

District Funds were used to provide and install 1 new relocatable classroom for a new Parent Resource Center.

The custodial staff adheres to a weekly cleaning schedule that includes classrooms, restrooms, cafeteria and kitchen areas.

The District’s Mobile Maintenance Team visits the school site at least twice a year. Maintenance emergencies are addressed immediately. District personnel maintain the grounds at least once every two weeks.

This site also is maintained to ensure a clean, safe, and functional facility as determined pursuant to a Facility Inspection Tool developed by the State of California Office of Public School Construction.

Opportunities for Parental Involvement (School Year 2017-18)

We believe that our parents/guardians are an extremely important and integral part of student learning at Wayside School. Wayside parents/guardians participate in a number of organizations including: School Site Council, District Advisory Committee, District English Learners Advisory Committee, and our PTA. We provide a variety of educational opportunities for our parents/guardians such as classes in English-as-a-Second Language, GED, and Parenting Skills. Our Principal holds monthly meetings for parents that cover such topics such as effective discipline, standards-based instruction, nutrition, developmental growth, and child abuse prevention. These monthly meetings also afford our parents/guardians multiple opportunities to ask questions about how they can effectively collaborate with our school and become active partners with us in the education of their children. Our parent groups organize, sponsor and attend several major activities and events including: Back-to-School Night, Family Dance, skating parties, field trips, quarterly awards ceremonies, Staff Appreciation luncheon, and our end-of-year programs.

Wayside has an active and supportive parent community along with a dynamic administrative support staff which work together to provide a full-range of services to learning community. Some of these services include translation, referrals for clothing, emergency food, medical and/or mental health treatment and counseling, other links for families to services in the community, and transportation to such services. Specifically, our children and parents/guardians participate in the Kiwanis Community Readers, Costco Star Readers Program, and Volunteer Center for food baskets at Thanksgiving and Christmas. Wayside has an active Parent Volunteer program and recruits and trains all parents and community members willing to partner with us. Parents can call our school office at (661) 631-5820 to access information concerning participation opportunities.

We have a three-hour After School Program that serves over 150 students each school day. Many opportunities occur each month for our After School parents/guardians to actively participate in such as assemblies on health, transportation, motivation, behavior, and character building. The ASP has three periods a day: homework, art/music, technology, and sports, and also holds fun activities like dances and field trips.

We have numerous individuals, businesses and clubs that support or sponsor our school such as Applebees, Panda Express, Nestle, Dreyers, Bakersfield Kiwanis, Lions' Club, Southwest Lanes, Grace Assembly, Chester Avenue Community Church, Sizzler Restaurant, Golden Empire Transit, State Farm Insurance, HomeTown Buffet, Bakersfield Condors, Skateland, Macaroni Grill, and Golden Corral. Typically, these community organizations provide student incentives for excellent behavior, attendance, and academic achievement.

Wayside established its Comprehensive School Safety Plan in 1998. A law enforcement officer specializing in safety provided direction in the establishment of the School Safety Plan. Wayside's School Safety Plan is current and is updated annually. Our overall goal is to maintain a safe and orderly school environment conducive to learning.

Professional Development (Most Recent Three Years)

Professional development is designed to provide continuous learning opportunities for administrators, teachers, and classified personnel. Training opportunities affirm the basic philosophy of education that learning is a lifelong process that contributes to the well-being of the students, teachers, administrators, and community. Professional Development is an essential component of effective instruction and student learning.

All training revolves around identified needs of students and adults for the purpose of the improvement of instruction and increasing content knowledge. Central to all training are student achievement data, district focus areas, the Common Core State Standards, the state adopted standards-based instructional materials, and strategies to effectively teach the academic content standards to all students.

The district created professional development based on the Common Core State Standards for teachers and administrators. The modules included a Common Core overview, Mathematical Practices, Cross-Curricular/Evidence Based Writing, Text Complexity/Academic Vocabulary and the new ELD standards for California. We also provided extensive professional development for Professional Learning Communities through the use of Guiding Coalitions to school site and district teams. On-site coaching and support is provided by academic coaches for reading/language arts and mathematics. The district provides time and resources for collaboration, planning, and professional development. Additionally, we provided professional development on Positive School-wide Behavior Intervention and Support to school and district teams.

Teachers new to the District received four days of professional development prior to the beginning of the school year focused on orientation to District and school site policies and services, Common Core State Standards, classroom management, curriculum and pacing, and setting up the classroom. Teachers in their second year with the District received two days of professional development prior to the beginning of the school year focused on best practices for improving student achievement.

New teachers with California preliminary credentials received professional development through the Beginning Teacher Support and Assessment (BTSA) program. The focus of training was in the Formative Assessment for California Teachers (FACT), California Standards for the Teaching Profession (CSTP), meeting the California Induction standards, and the California Academic Content Standards. Each beginning teacher was assigned a veteran teacher who served as a support provider. The support providers received on-going professional development in FACT, coaching strategies, and instructional techniques. Professional development was provided through individual mentoring, monthly meetings, and after-school workshops.

Intern teachers received professional development at monthly meetings focusing on the initial teaching skills of the CSTP including classroom management, lesson planning, assessment, and establishing a climate that is conducive to student achievement. Each Intern was assigned a support provider that provided day-to-day support in these areas as well as advisement toward meeting credential requirements. Support providers received monthly professional development in meeting the needs of Intern teachers. Interns also received coursework and supervision from universities partnered with BCSD to provide the Intern Program.
