X. REPORTS

X.a. Superintendent's Report

Minutes:

Superintendent Kessler gave the following report:

Normally at this time I like to use the Superintendent's Report as a platform to highlight the wonderful activities and accomplishments of our students and staff.

Today however, in the first part of my report I will be directing my remarks to a few current district issues to the Board of Education, students and staff, as well as the community of Beverly Hills.

The first issue I wish to speak about is the issue of homework. Homework, per our existing Board of Education policy that is appropriate, purposeful and balanced has been shown to be of great benefit towards gaining academic success. Conversely, homework that is shown to be not appropriate or purposeful or balanced can be of great harm to our students as well as our families.

We must insure that the recommended homework guidelines established by the Board of Education are followed. Those guidelines state that our students can be expected to be assigned 10 minutes of homework per night in 1st grade, followed by 15 minutes per night in 2nd grade, 20 minutes in 3rd grade, 40 minutes in 4th grade and finally 60 minutes per night in 5th grade. Once our students enter middle school the expected amount of homework in 6th grade is 90 minutes per night with our 7th and 8th graders to be expecting 120 minutes of homework each night. Honors courses can also expect an extra of homework per night. At BHHS our students can expect 3 hours per week per subject which averages out to approximately 35 minutes per class per night. AP and honors courses can also expect extra homework.

I agree with these guidelines. They are well thought out and based on research. I have already started discussions with our BHEA representatives, as well as our administrative staff at each school so that all are part of a collaborative effort to make sure that these homework guidelines are being followed. Part of that discussion will be the issue of multiple tests on certain days. I will be reporting out on this issue at our next

Board meeting scheduled for Feb. 23rd after completing my discussions with the BHEA and our administrative staff.

The next issue is that of the graduation requirements at BHHS. I was so pleased to see at our special Board study session a free exchange of thoughts and ideas from all the stakeholders of the district on this important subject. At that study session, staff presented different pathways to satisfy the graduation requirement without effecting the A-G requirement. The Board and community then weighed in with their own thoughts and ideas. Staff has listened carefully to the Board along with teachers, parents and community members regarding their important ideas. We are currently blending all these ideas into an updated BHHS Graduation Requirements document that will be an agenda item for the Board's consideration at our next Board meeting on Feb. 23rd.

Many of my thoughts as Superintendent have centered on a plan of action for our district. As Superintendent I have had 8 months now to get settled in and take a real inventory of the district. In that regard I have begun the process of establishing our district's mission, vision and goals along with specific administrative and leadership goals for our district. The development of these goals will be done hand in hand with the Board of Education, our administrative team and community. These preliminary goals will be presented by staff at our March 29th Board meeting for the Board's consideration and input. I am hopeful that the community of Beverly Hills will also weigh in on these goals through our scheduled town hall meetings. Ultimately, that will culminate in the defining of specific administrative and leadership goals at our administrative retreat scheduled for August 1st. At that retreat, our administrative team led by an outside facilitator will develop action plans per the recommendation of Vice President Spitz as a way for clearly defining district administrative and leadership goals.

I am very excited about our future. We have a lot to look forward to but not without challenges. We have a tremendous opportunity to modernize our schools both inside and outside the classroom. We have a Board that is giving clear direction and working together for the greater good of all. In that regard I hope the Board will join me at the CSBA conference scheduled for March 4th in Anaheim. The CSBA has proven a valuable resource over the years and an organization that can be of service to the district.

The district protocol that is now being followed regarding school security, BHHS graduation requirements, homework and now our district's goals, illustrate a new day in the district and one in which I am confident will yield the best results for our students and our district.

The last few weeks have been very productive for our students at BHHS. I am pleased to report that our BHHS Science Olympiad Team at the Polytechnic Invitational scored first place in experimental design along with 2nd place for Green Generation and Game On, as well as 3rd place in the Chemistry Lab division.

Our CTE program under the direction of Cindy Dubin had 10 of their 25 students who entered the USA Regional Skills Competition qualify for the State Finals.

At the scholastic art and writing region competition for BHHS Technical Arts directed by Tim Briggs, the technical arts chair for BHHS, we had 9 students recognized for their achievements in photography as well as one student recognized for architecture.

The icing on the cake was delivered when the ranking of the Top 100 elementary schools in California was released by Niche this week. Niche bases its ranking on "a comprehensive assessment of the overall experience of a public elementary school. This grade takes into account key factors such as the strength of academics, quality of teachers, diversity, as well as the overall quality of the school district."

BHUSD had two K-8 schools in the top 50, and three in the top 100.
