School Description and Mission Statement (School Year 2017-18)

At Miner School in South San Jose's Oak Grove School District, all stakeholders know that student success takes leadership, vision, a map, exemplary staff, quality teaching, supportive parents/community, and resources. Miner School is the core to our community. Our students may begin their day with breakfast at school. At morning announcements, one student from every class is publicly recognized for being respectful, responsible, safe, or kind. Throughout each day, students are explicitly taught what is expected of them, and why they are learning what they are learning - be that in regard to academics or behavior.

In a shared leadership mode, the principal, staff, parents, and partners maintain a laser-sharp focus on their vision, follow a detailed map, and plan alternate routes to meet the needs of students. Decisions are based on the best interest of ALL students, with a focus on our English Language Learners. Comprehensive assessment is the first step in mapping our journey, knowing that student performance data drives curriculum, instruction, professional development, and the allocation of resources. In accordance with the Common Core Standards, students work around the Four C's: Cooperation, Collaboration, Communication, and Creativity.

As a SEAL (Sobrato Early Academic Language) school, all of our Transitional Kindergarten through fifth grade classes are immersed daily in highly academic language development through well-developed integrated units of study. These engaging units integrate science or social studies content with English Language Arts. As a SEAL Demonstration site, our classes welcome many visitors throughout the year from school districts across the state. Our students love to share what they are learning!

Students are held responsible for their learning and are provided opportunities to evaluate their work, based on standards-based rubrics. Teachers post focus skills and standards to inform students of their learning goals and give timely feedback to students. Regular, frequent communication is maintained with parents in a variety of ways. Parent education targets curriculum content, knowledge about standards, and strategies for helping their child(ren) at home. Gifted and high-achieving students are challenged with higher-level skills; students not proficient are provided appropriate safety nets during and beyond the school day. Many Miner students extend their school day with classes in reading or math, or with membership in the Boys and Girls Club on campus.

Continuous improvement is the mode at Miner School.

School Facility Conditions and Planned Improvements

As per the Williams’ settlement, all Oak Grove schools are maintained in a manner that assures a clean, safe, and functional site as determined by periodic evaluation.

Measure P: On November 4, 2014 the voters in Oak Grove School District approved the issuance of Measure P. Measure P authorized the issuance of \$89.8 million in bonds to benefit the Oak Grove School District. The funds are meant to be used to renovate, repair, acquire, construct and modernize classrooms and facilities, and increase student access to computers and technology.

During the summer of 2015, 2016 and 2017, ten school sites (Anderson, Bernal, Davis, Del Roble, Edenvale, Oakridge, Parkview, Herman, Hayes and Sakamoto), had over approximately 38 million dollars of HVAC and Roofing renovations completed.

After the successful completion of the Measure Q Bond program, the Oak Grove community approved Measure S in November 2008 that authorized an additional \$125 million General Obligation Bond to continue needed school modernization projects, construct two new intermediate school gymnasiums, and consider solar technology systems throughout the district. Combined with local Routine Repair funds and State Deferred Maintenance funds, future facility improvements will insure that critical services continue to be provided for our students for years to come.

Parents have many opportunities to participate in the educational programs at Miner School. We have many parents who choose to volunteer in their child’s classroom, working with individual students or doing copying and prep work for the teacher. Parents volunteer to attend field trips and to help with school events. Parents assist our Community Liaison in the preparation of materials for these activities.

Parents are invited into the classroom to attend Gallery Walks at the end of SEAL units in TK-5th grade, and Project Presentations at the end of PBL units in grades 4-6.

Our Home and School Club has several fundraisers each year and volunteers are an important part of these activities. We meet on a monthly basis and plan activities such as the Miner Marathon and other fundraisers. At the beginning of each school year, we invite parents to join our School Site Council, which consists of parents and staff. We have several SELAC meetings each year for our second language parents to discuss the specific educational challenges their students face while learning English.

Parents are invited to attend classes/seminars throughout the year on topics related to parenting skills, navigating the school system, and how to read with and work with their children at home.

School Safety Plan – Most Recent Year

Providing a safe environment is a high priority for Miner School. To this end, there are continuous improvement processes and collaborative efforts that provide comprehensive health education and a strong academic foundation within a safe and secure learning environment.

Prevention education at Miner includes supplemental programs and policies including School-wide Positive Behavior Support System (PBIS); positive discipline; drug, alcohol, substance abuse; tobacco prevention education; health and nutrition-based assemblies; anti bullying; and the Wellness Policy including physical education and nutritional education.

Attendance is closely monitored and students with unexcused absences of 10% or more receive law/school district/partnership intervention. Truancy abatement is a common goal of the school/district and other agency collaborative partnerships. Currently Miner has instituted an Attendance Incentive Program, which is targeting attendance and tardies. We use EdConnect to notify parents daily of student absences.

In order to reduce the number of incidents of bullying and harassment among students and to insure that students feel neither intimidated nor threatened by bullying or harassment, Miner has an ongoing program that specifically addresses issues of race, ethnicity, gender, sexual orientation, perceived sexual orientation, and perceptions which commonly surface in bullying/harassment incidences. All students and staff at Miner are trained in effective ways to deal with offensive behavior through Positive Behavior Intervention Strategies.

We also have ongoing classroom instruction and use social settings inside and outside the classroom to focus on the life skills of empathy, anger management, and problem solving.

Each year, staff is educated, trained, and practices the concepts of the National Emergency Management System which includes fire drills, earthquake evacuation, first aid procedures, communicable disease action plan, and emergency evacuation maps.

We believe that students, once taught the desired school behaviors, will display those behaviors. We balance the school discipline plan with positive incentives, as well as appropriate alternative consequence plans. School-wide expectations are posted in each classroom, and in many locations throughout the school. Positive incentives are offered for positive behavior/attitude, good attendance, positive practices, and academics. Alternatives reviewed as options to positive discipline include campus clean-up, campus projects, incentives, community services, behavior plans/contracts, site or off-site group or individual counseling, and/or alternative placements.

We strive to improve the system of publications to students, staff, and community which will include or focus on student awards/recognition, rewards, school activities, achievements, acknowledgments, and announcements.

Professional Development

This section provides information on the annual number of school days dedicated to staff development for the most recent three-year period.

Our school provides extensive training for teachers in the implementation of standards, development of effective assessment, English Language Development, and understanding the Closing the Achievement Gap Plan. There are numerous opportunities for participation in district in-services, out-of-district conferences, workshops, and committees. There are three AB 1579 days each year, when students do not attend school and teachers are involved in professional development. Additionally, one day each week students are dismissed early to allow teachers to work with their grade level teams, and/or participate in continued professional development. Currently, our TK-5th grade teachers are receiving professional development through the Sobrato Early Language Learning (SEAL) initiative. This is ongoing, intensive training in understanding the ELA and ELD Common Core Standards and strategies through which to teach them. These strategies focus on high academic language, oral language engagement, reading and writing. Staff have also been trained in providing Systematic English Language Development to students learning English, with continuing professional development. We have a leadership team/continuous improvement team that leads site staff development around analyzing student work, developing effective strategies for the classroom, and using grade level time to improve instruction. Teachers this year are participating in ongoing training using the Writers' Workshop model. Staff development is determined by looking at data and based on student needs.
