## School Description and Mission Statement (School Year 2016–17)

Ledesma School is one of nineteen schools in the Oak Grove School District, a district that is committed to developing an inclusive, caring educational community in which each individual has an equal opportunity to achieve his or her potential. Ledesma's goal is to provide a well-balanced, strong curricular program that meets the needs of each student and continues to keep high standards and hold students, staff, and parents to them. We are implementing the Common Core State Standards to ensure Ledesma students are career and college ready. We want to provide a literacy-based instructional program that meets and exceeds the district standard of all students reading and writing on grade level by third grade; provide a school culture where all people can openly communicate, share ideas and work together to meet the challenges of school life; provide on-going parent training for all parents in order to help them understand the school and student expectations; provide a learning environment where all children feel safe and respected; and continue our three-year focus on improving writing at all grade levels. The Kindergarten through third grade classrooms all implement a language enriched program, SEAL. Our fourth through sixth grade classrooms all implement Project Based Learning (PBL). Both SEAL and PBL enrich students vocabulary, speaking and communication skills through collaboration, writing and speaking while studying specific standard based units.

## School Facility Conditions and Planned Improvements

As per the Williams' settlement, all Oak Grove schools are maintained in a manner that assures a clean, safe, and functional site as determined by periodic evaluation.

Measure P: On November 4, 2014 the voters in Oak Grove School District approved the issuance of Measure P. Measure P authorized the issuance of \$89.8 million in bonds to benefit the Oak Grove School District. The funds are meant to be used to renovate, repair, acquire, construct and modernize classrooms and facilities, and increase student access to computers and technology.

After the successful completion of the Measure Q Bond program, the Oak Grove community approved Measure S in November 2008 that authorized an additional \$125 million General Obligation Bond to continue needed school modernization projects, construct two new intermediate school gymnasiums, and consider solar technology systems throughout the district. Combined with local Routine funds and State Deferred Maintenance funds, future facility improvements will insure that critical services continue to be provided for our students for years to come.

### Opportunities for Parental Involvement - (School Year 2016–17)

Ledesma School has a strong parent volunteer program. There are many ways to provide support for students and teachers. Parent volunteers can work one-on-one with a student for thirty minutes once or twice a week providing tutoring in language arts and/or math. Parent volunteers can work in the classroom reading to students, or helping the teacher with paperwork on a regular basis for up to one hour per day. Volunteers can work as a noon duty at lunchtime to help support the safety of our students. Parents may work in the office copy room to make copies of homework or other curricular materials needed by the teacher. Parents are encouraged to take an active role in some of the school wide educational programs that expand on our students educational needs. Such programs are Art Vista, Room Parent, Positive Behavior Intervention Systems trainer and other additional school wide programs. All school volunteers need to attend parent volunteer training given on an on-going basis throughout the year. Parents also have ample opportunities to volunteer for school fundraisers and community building events such as Movie Night chair person, Walk A Thon, Festival chair person and other individual activities that our Home and School Club offers through out the year. Parents can serve on the Home/School Club Board and can run each year for a seat on the School Site Council.

### School Safety Plan – Most Recent Year

Providing a safe school is a high priority for Ledesma School. To this end, there are continuous improvement processes and collaborative efforts that provide comprehensive health education and a strong academic foundation within a safe and secure learning environment that ensures success for all students.

Prevention education at Ledesma includes supplemental programs and policies including conflict/peer mediation, PBIS (Positive Behavior Intervention Support), bullying, harassment, developmental assets, and the Wellness Policy including physical education and nutritional education.

Attendance is closely monitored and students with unexcused absences of 10% or more receive law/school district/partnership intervention. Truancy abatement is a common goal of the school/district and other agency collaborative partnerships. Currently Ledesma has instituted an Attendance Incentive Program, which is targeting attendance and tardies.

In order to reduce the number of incidents of bullying and harassment among students and to ensure that students feel neither intimidated nor threatened by bullying or harassment, Ledesma has an ongoing program that specifically addresses issues of race, ethnicity, gender, sexual orientation, perceived sexual orientation, and perceptions which commonly surface in bullying/harassment incidences. Staff has been trained on Bully Proofing and they have taught Bully Proofing lesson in each of their classrooms.

We also have ongoing classroom instruction and use social settings inside and outside the classroom to focus on the life skills of empathy, anger management, and problem solving.

Each year staff is educated, trained, and practices the concepts of the National Emergency Management System which includes fire drills, earthquake evacuation, first aid procedures, communicable disease action plan, and emergency evacuation maps.

We balance the school discipline plan with positive incentives, as well as appropriate alternative consequence plans. School-wide rules are posted in each classroom. Positive incentives are offered for positive behavior/attitude, good attendance, positive wellness, and practices, academics. Alternatives reviewed as options to positive discipline include campus clean-up, campus projects, incentives, community services, behavior plans/contracts, site or off-site group or individual counseling, and/or alternative placements.

We strive to improve the system of publications to students, staff, and community which will include or focus on student awards/recognition, rewards, school activities, achievements, acknowledgments, and announcements.

## Professional Development

This section provides information on the annual number of school days dedicated to staff development for the most recent three-year period.

Our school provides extensive training for teachers in the implementation of Common Core State Standards, development of effective assessment, and understanding the Closing the Achievement Gap Plan. There are numerous opportunities for participation in district in-services, out-of-district conferences, workshops, and committees. Currently much emphasis at the site level has been dedicated to understanding Number Talks, Close Reading, Text Dependent Questions, the four Math Claims, Technology within the classroom, Equity, Cycle of Inquiry, Guided Reading, Systematic English Language Development (SELD), Strategies for Students with Behavioral Challenges, and PBIS (Positive Behavior Intervention Support). Kindergarten through third grade teachers have been trained in SEAL. All fourth through sixth grade teachers have been trained in Project Based Learning. The staff has also been trained in providing English Language Development to the students learning English. We have an equity/continuous improvement team that leads site staff development around analyzing student work, developing effective strategies for the classroom, and using grade level time to improve instruction. The Ledesma staff will continue professional development and learn more about implementing CCSS strategies with rigor, relevance and/or learner engagement.
