Mission Statement:

Mission Statement: We will provide ALL students with an educational foundation that will prepare them for higher education. Students will become literate, life-long learners with a positive, productive role in society. Edgemont Elementary School is a modified traditional K-5 school. It is located in a culturally diverse area with a population of approximately 740 students, the majority of whom arrive by bus. The surrounding neighborhood is rapidly changing with the construction of many new shopping and eating areas. Built in 1956, Edgemont Elementary School is one of the District's oldest elementary schools; however, classrooms and offices were renovated in 2002 as part of California's School Modernization Program. New outdoor playground equipment was also installed. A new lunch shelter was recently installed to the north side of the multipurpose room. Buildings and grounds are clean and attractively maintained. Edgemont's population is composed of families in which one or both parents work, although 95% of students participate in the free or reduced-cost meals program. Breakfast is served daily to ensure that all students have a healthful start.

A "Head Start" Program for preschoolers and a "Think Together" after-school program (open to all grade levels) are also offered on site. Edgemont has also developed many "Adopt-a-School" partnerships with various community organizations. Many of these partners have maintained an active role at Edgemont for several years and many more are added each year. Community partnerships for 2014-15 included Freedom House Church, East Hills Community Church, the Morongo Band of Mission Indians, Potter's House Christian Fellowship, Pepsi-Cola Company, Riverside Creamery/Kroger Manufacturing, Golden State Foods Foundation, Horace Mann Insurance, Lowe's, Costco, Altura Credit Union, BJ's Restaurant, Shakey's Pizza, and Assistance League of Riverside. Organizations in partnership with Edgemont Elementary School provide support in a variety of forms such as donations of gifts, food, and funding, academic and attendance incentives, tutoring, school supplies, playground supervision, and volunteer personnel at various events.

A School Counselor coordinates "Parenting with Dignity" workshops, food drives, emergency assistance, and student incentive programs in cooperation with parents, partners, and staff committees. A Community Liaison establishes and maintains partnerships between the school and parents and various organizations in the community. The Liaison also works closely with parent organizations such as ELAC and Parent Boosters.

Edgemont students are consistently recognized for their accomplishments. Academic accomplishments are recognized at trimester awards assemblies. Students making progress in the "Accelerated Reader" and "Math Masters" Programs are recognized with special awards, certificates, and prizes. Improving student attendance is a priority, therefore, weekly, monthly, trimester, and annual incentives are awarded to select students with perfect attendance. Students displaying appropriate citizenship and behavior are rewarded with "Green Tickets" and "Noon Duty Dollars." These Green Tickets and Noon-Duty Dollars are exchanged for prizes. At Edgemont Elementary School, students are taught "The Edgemont Code of Conduct" (which is based on fine character traits) and the "Golden Rule." ("Treat others how you would like to be treated."). The Golden Rule is announced daily during morning announcements along with a short definition of one of the "Six Traits of Fine Character" (Trustworthiness, Respect, Responsibility, Fairness, Caring and Citizenship). Weekly Character Awards are presented by the Principal in every classroom and the award recipients are permitted to choose a prize from the School's Treasure Box.

The school counselor, teachers, staff and administrators consistently reinforce fine character traits, perfect attendance, and high academic achievement when working with students and their families. A positive school climate is promoted and reinforced with the "Eagle Pride" cheer which is recited at the Student-of-the-Month Assemblies. Students-of-the-Month also recite this cheer when attending "Lunch with the Principal" at Shakey's Pizza Parlor. Finally, Edgemont Elementary School promotes high academic achievement by providing opportunities to engage in extra-curricular competitions such as Spelling Bees, reading competitions (Lefty's Reading Challenge), math challenges, History and Science events, and participation in world-wide internet activities such as the international "Hour of Code"

Quality, Currency, Availability of Textbooks and Instructional Materials (School Year 2014-15)

The District provides all students with high-quality textbooks and instructional resources. Instructional materials are reviewed and approved by State committees for local adoption in grades K-8; high school materials are reviewed and approved locally. All core instructional materials are reviewed by District level committees of teachers and administrators and approved by the Board of Education prior to use within MVUSD schools. This process is aligned with the State Department of Education's seven-year review cycle. The State Board's adoption cycle is: • 2004-05: Health • 2005-06: History-Social Science • 2006-07: Science and Visual & Performing Arts • 2007-08: Mathematics • 2008-09: Reading-Language Arts The District normally adopts new material within twenty-four months of adoption by the State Board of Education. As a result of state budget shortfalls, Assembly Bill X42 (Chapter 2, Statutes of 2009-10 Fourth Extraordinary Session) signed on July 28, 2009, suspended the process and procedures for adopting instructional materials, until the 2013-14 school year and allowed districts to postpone. Each school has a library to supplement and enrich the school's instructional program. In accordance with Education Code Section 60422(a) and 60119, the Governing Board certified on 9/28/2010 that each pupil in the district, in kindergarten through grade twelve, has been provided with standards-aligned textbooks or basic instructional materials in each of the areas listed below (0% lack textbooks and/or instructional materials in any of the listed areas). The chart below outlines the textbooks adopted and used by Moreno Valley Unified School District.

School Facility Conditions and Planned Improvements (Most Recent Year)

General:

The District takes great efforts to ensure that all schools are clean, safe, and functional. To assist in this effort, the District uses a facility survey instrument developed by the State of California Office of Public School Construction. The results of this survey are available at the District office, or on the Internet at www.mvUSD.k12.ca.us. Listed below is more specific information on the condition of the school and the efforts made to ensure that students are provided with a clean, safe, and functional learning environment.

Age of School Building:

This school has 39 classrooms, 21 permanent classes, 18 portables, a multipurpose room, a library, and an administration building. The main campus was built in 1956. The school opened in 1956.

Maintenance and Repair:

District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and all emergency repairs are given the highest priority.

Cleaning Process and Schedule:

The District governing board has adopted cleaning standards for all schools in the District. A summary of these standards is available at the District's M & O office. The District Custodial Supervisor works daily with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

Improvement Projects:

Improvement projects recently completed at the school include a concrete ribbon gutter drainage installed.

Deferred Maintenance Budget:

The District participates in the State School Deferred Maintenance Program, which provides State-matching funds on a dollar-for-dollar basis, to assist school districts with expenditures for major repair or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting, and floor systems. For the 2008-09 school year, the District has budgeted \$1,280,000 for the Deferred Maintenance Program. This represents 0.44% of the District's general fund budget.

Opportunities for Parental Involvement

Parents and community members have many opportunities to become involved in site activities and events. We believe that student success is contingent upon a strong school and parent connection and, therefore, we offer many activities for parents and students.

Opportunities for school involvement include Parent Booster Club, School Site Council (SSC), and the English Language Advisory Committee (ELAC). There are also several clubs in which Edgemont families participate including the "Terrific Tuesdays" Sewing Club and the "Healthy Mothers" Fitness Club. Parent volunteers are encouraged and rewarded with "Volunteer Value Bucks" that can be exchanged for prizes at our end-of-the-year auction. Community partners and parent volunteers are recognized at our annual Volunteer Luncheon that occurs in the spring.

In addition to involvement opportunities, a parent-student compact that describes school and parent responsibilities to support academic achievement was developed by staff and parents. A parent "needs assessment" is conducted annually and parent workshops and classes are planned based upon the results. These include a variety of topics including homework help, reading strategies, Standardized Testing and Reporting (STAR) California Standards Test program, childhood health, family nutrition, breast cancer awareness, neighborhood safety, and child safety seats. In addition parenting classes (Parenting with Dignity and SMART Discipline) and family literacy classes are offered on an ongoing basis.

Edgemont also conducts monthly evening family events planned by the Parent Involvement Committee and supported by the Edgemont Booster Club and Friday Night Live Kids. "Family Fun Night" takes place four times per year to provide families with a fun, educational evening with teachers and staff. Several academic evening events including Family Math Night, Test-Taking Strategies, and Family Literacy Fiesta, provide parents with strategies to assist their students with academics. In addition, parents are invited to celebrate their student's success at awards assemblies each trimester. Parents can also support Edgemont by joining staff at McDonald's on "McTeacher's Night."

School Safety Plan

Edgemont Elementary annually reviews the Safe School Plan and the Disaster Preparedness Plan. The Safe School Plan summarizes the current status of school crime committed on school campuses and at school-related functions, the identification of appropriate strategies and programs that will provide or maintain a high level of school safety, and addresses procedures for complying with existing laws related to school safety. The Plan also includes the District discipline policy, which gives the consequences for student misconduct (such as detention, Saturday School, suspension, and expulsion).

The Disaster Preparedness Plan outlines guidelines and procedures for responding during disasters and emergency situations. Fire drills are held once a month and earthquake drills are done quarterly.

The School Safety Plan was last reviewed, updated, and discussed with school staff on September 12, 2011.

Types of Services Funded at Edgemont Elementary School

The average daily attendance (ADA) dollars provide services budgeted from the general fund including regular classroom instruction and support, special education, counseling, psychology, child welfare, and attendance and program assessment. Additional services funded as categorical programs include: Title I, and Title VI assistance to targeted populations, services for English Learners, Gifted and Talented Education (GATE), School Safety and Violence Prevention, and before- and after- school tutorial programs.

Professional Development provided for Teachers at Edgemont Elementary School

Professional development is designed to support the implementation of the school's plan by promoting curriculum improvement training programs focusing primarily on grade level academic content standards instructional strategies, assessment (data analysis and content training), review processes, individual school needs, and needs of special students. Such programs focus on analysis of teaching and student learning, accountability strategies, and integration of technology into the District's curricula. The Professional Development Specialists have also been trained in the Professional Learning Community model and are available for assistance with implementation on our campuses. Our schools also benefits from the various professional programs available to staff through District support. Some of these opportunities are:

- Teachers with preliminary credentials new to Moreno Valley are provided the opportunity to clear their credentials through the Induction Program coordinated by Professional Development and RCOE.
- Multilingual and Special Education trainings are all coordinated through Professional Development. CPR and Instructional Assistant trainings are also coordinated through Professional Development
- Participants may register electronically for professional development offerings.
- Local colleges and universities offer a wide variety of professional development coursework.

Teachers are compensated for attending professional development during their non-contract time. Substitutes are provided through various funding sources for trainings taking place during the school day. Professional Development works collaboratively with teacher-teams to develop Scope and Sequence manuals for teaching the Common Core State Standards. The department also facilitates teams for the creation of the new Interim Assessments. The Professional Development department is moving away from the traditional 'workshop' method of providing teacher training and is moving towards a coaching model where our twelve specialists spend a day at each school site collaborating with the staff and administration to analyze data and develop plans for increasing student achievement. Each specialist has had in-depth training on implementing the Common Core State Standards and with school staffs to implement the changes using a transformational model. Professional Development also plans and hosts the Leadership Academy for developing teacher leaders.
