The vehicle pulled out and collided with the lower right side of the bus. No injuries were reported and a Police Report was made.

**DAMAGE:** The damages to the school bus are mainly to the area behind the right front wheel and the storage compartment. The cost of repairs, based on the estimate provided by Davis Truck Painting Inc., is \$10,262.29.

**LIABILITY:** The liability in this matter rest with the other party for failing to yield the right way to the bus.

**RECOMMENDATIONS:** It is our recommendations that the School District grants the approval to pay this claim.
