RESOLUTION NO. 167-12
RESOLUTION BY THE BOARD OF TRUSTEES OF THE CYPRESS SCHOOL DISTRICT APPROVING DRAFT TRUSTEE AREA MAPS AND POTENTIAL SEQUENCE OF THE ELECTIONS FOR DISCUSSION AT COMMUNITY MEETINGS; ESTABLISHING THE DATES, TIMES, AND LOCATIONS OF THE COMMUNITY MEETINGS; AND IDENTIFYING ADDITIONAL FUTURE ACTION TO BE CONSIDERED BY THE BOARD.

RECITALS

WHEREAS, at its meeting of January 19, 2017, the Board has considered three draft trustee area maps proposing that each Board member reside in a trustee area and be elected by the registered voters of that particular trustee area (Education Code section 5030(b)); and

WHEREAS, at the meeting, the three draft trustee area maps, including potential sequence of elections, were presented by Dr. Justin Levitt of National Demographics Corporation, copies of which are attached to this Resolution as draft maps 1, 2 and 3; and

WHEREAS, the purpose of presenting the three draft trustee area maps and potential sequence of the elections is to have the Board authorize presentation of the maps to the public at community meetings in order to receive public input and address any questions or concerns the public may have with respect to changing the District's election methodology; and

WHEREAS, the Board desires to receive the public's input with respect to the draft maps and potential sequence of the elections.

NOW, THEREFORE, BE IT RESOLVED that the Board hereby finds the foregoing recitals to be true and correct; and

BE IT FURTHER RESOLVED that the Board directs that draft maps 1, 2 and 3 and the potential sequence of elections be presented by National Demographics Corporation at community meetings for public comment and discussion; and

BE IT FURTHER RESOLVED that community meetings for the purpose of receiving further public input on the draft maps and sequence of elections be held as follows: on January 30, 2017, at 11 a.m. in the Board Room at the District Office, located at 9470 Moody Street, Cypress, California 90630, and on February 1, 2017, at 6:00 p.m. in the multipurpose room at Margaret Landell Elementary School, 9739 Denni Street, Cypress, California 90630; and

BE IT FURTHER RESOLVED that the Superintendent or designee is directed to disseminate to the public information as to the time, place and purpose of the meetings at which the community is invited to provide its input with respect to the draft maps and sequence of the elections; and

BE IT FURTHER RESOLVED that the Board directs National Demographics Corporation to report back to the Board at its meeting of February 16, 2017, or as soon thereafter as the matter may be considered, with respect to the comments received at the community meetings, and present any recommended changes to the draft maps and sequence of the elections which should be considered by the Board based on public comment; and

BE IT FURTHER RESOLVED that if further amendments to the draft maps are either not recommended by National Demographics Corporation, and the Board agrees, or no changes are directed by the Board, the Board will schedule two public hearings on the maps and plans as required by Elections Code section 10010. If the Board determines to proceed in this manner, the Superintendent or designee will provide notice to the public of the hearings with respect to draft maps in the following manner: Publication on Cypress School District website, email to district parents, and press release to local media.

BE IT FURTHER RESOLVED that, in the alternative, if changes to the draft maps and plans are recommended by National Demographics Corporation, and directed by the Board, or requested by the Board, such changes will be brought back to the Board for consideration at a subsequent meeting of the Board, at which time the Board may schedule two public hearings to be held pursuant to Elections Code section 10010; and

BE IT FURTHER AND FINALLY RESOLVED that following the second public hearing the Board will, in a separate public hearing, consider adoption of a final map and plan for submission to the Orange County Committee on School District Organization on such date as the Board may deem appropriate.
