

Oak Meadows Elementary Parental Involvement Policy

PART I. GENERAL EXPECTATIONS

Oak Meadows Elementary agrees to implement the following statutory requirements:

1. The **Oak Meadows Elementary** will take the following actions to involve parents in the joint development of its school parental involvement plan under section 1118 of the ESEA: We encourage parents to join the Parent Teacher Organization (PTO) and Campus Advisory Team (CAT). During both the PTO and CAT meetings, parents are informed of how Title I funds are spent and the results of state assessments. PTO meetings are frequently held in conjunction with other campus activities to encourage campus-wide attendance.
2. The **Oak Meadows Elementary** will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA: We encourage parents to join the Parent Teacher Organization (PTO) and Campus Advisory Team (CAT). During both the PTO and CAT meetings parents are informed of how Title I funds are spent and the results of state assessments. PTO meetings are frequently held in conjunction with other campus activities to encourage campus-wide attendance.
3. The **Oak Meadows Elementary** will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting, and will encourage them to attend, by: Inviting parents to participate in our Winter Literacy Night, or STAAR Night in January, and our Spring Literacy Night as well as a November Donuts with Dads and May Muffins with Moms morning events.
4. The **Oak Meadows Elementary** will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet by: Inviting parents to participate in a Fall Curriculum Night as well as Parent-Teacher Conferences throughout the year. Parents receive notification of their child's progress with regards to the Texas Student Success Initiative (SSI) at the beginning of the year, the middle of the year, and the end of the year.
5. The **Oak Meadows Elementary** will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by: scheduling meetings with administration and staff members as needed; arranging for classroom visits; and working with SPED staff, 504 staff, dyslexia staff and campus interventionists to provide support as needed.

6. The **Oak Meadows Elementary** will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by: Sending home the Confidential Student Report once received from the Texas Education Agency.

7. The **Oak Meadows Elementary** will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by: Sending home a letter to inform parents of the affected students.

8. The **Oak Meadows Elementary** will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph --

- the state's academic content standards,
- the state's student academic achievement standards,
- the state and local academic assessments including alternate assessments,
- the requirements of Part A,
- how to monitor their child's progress, and
- how to work with educators.

by hosting Curriculum Night in the Fall; hosting the Title 1 Annual Meeting in the Fall; and by hosting STAAR Night in January.

9. The **Oak Meadows Elementary** will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by: Sharing Literacy Night make and take materials to encourage home literacy.

10. The **Oak Meadows Elementary** will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by: Hosting PTO meetings, CAT meetings, PD during staff meetings, Literacy Nights, Fall Festival, and other family events.

11. The **Oak Meadows Elementary** will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, public preschool, and other programs. The school will also conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by: Hosting PTO meetings, CAT meetings, PD during staff meetings, Literacy Nights, Fall Festival, and other family events.

12. The **Oak Meadows Elementary** will take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand: OME will translate as many documents and forms of communication into Spanish as is possible given time constraints. The campus will utilize electronic spoken translation equipment during parent events.

PART III. DISCRETIONARY SCHOOL PARENTAL INVOLVEMENT POLICY COMPONENTS
