The Jackson Parish School Board met in regular session at 6:00 p.m. on September 14, 2015, at its regular meeting place, 315 Pershing Highway, Jonesboro, Louisiana. The following were present for roll call: Dennis Clary, Wade McBride, Mary Saulters, Gloria Davis, Calvin Waggoner and Gerry Mims. Melissa Perry was absent.

The meeting was called to order by President Dennis Clary.

Gloria Davis gave the invocation.

Gerry Mims led the board in the Pledge of Allegiance.

Motion was made by Wade McBride, seconded by Mary Saulters and carried to approve as presented minutes of the meetings held August 3 and 27, 2015.

Motion was made by Mary Saulters, seconded by Gloria Davis and carried to approve out of state travel for Cherrise Bryan and Bertha Robinson to attend the College-Ready Writers Program in Minneapolis, Minnesota, on Thursday, November 19, 2015. All expenses to be paid by "Investing in Innovation (13)" grant administered by Northwestern State University Writing Project.
